#### **TRAINING OPTIONS**

On-Site Certification offers hourly training, as well as 64-hour Certificates of Completion. Each Certificate of Completion is 64 contact hours in length. A Certificate of Completion is a document of record stating that an individual has met all the requirements of the course, which includes being present for all 64 contact hours. Contact hours are actual hours spent in the laboratory and/or classroom. "Testing Out" or requesting to demonstrate the ability to perform the requirements without taking the entire course is not an acceptable means of attaining a Certificate of Completion, which by its very nature is used to provide a demonstrated ability to start and complete a course within its entirety. On-Site Certification does not accept training, education, contact or credit hours or certifications from schools, other facilities, trade programs, or colleges in exchange for Certificates of Completion or issuance of Welder Certifications. Any Certificate or Certification offered at our establishment must be earned entirely within our programs and methods of training.

#### **ATTENDANCE POLICY**

Following through with commitments and obligations is a key element in the functionality and success of any individual, company or organization. Attendance is one of the fundamental factors in acquiring a Certificate of Completion from On-Site Certification, as well as elemental in preparing individuals to be dependable and reliable employees and productive members of the workforce. We understand that sometimes unavoidable circumstances arise that are not within our reasonable control. In the event a client is unable to attend a session as scheduled, it is a requirement to contact the office to notify of an inability to attend training. A client with repeated cancellation occurrences, at the discretion of On-Site Certification, could be removed from the Certificate course and awarded a "W." Additionally, any individual who demonstrate repeated tardiness or repeated cancellation occurrences may be denied future involvement or be required to adhere to an altered payment structure.

# **SCHEDULING / CANCELLATIONS**

On-Site Certification's training structure allows for our clients to schedule training that best accommodate his/her availability. To schedule training, a welding booth must first be reserved. To reserve a welding booth, clients must contact On-Site Certification or utilize the means of scheduling as communicated by On-Site Certification staff. Should a client arrive without a reservation, accommodations may be made. However, those with a reservation are guaranteed their scheduled time slot(s). In the event a client is unable to attend scheduled training, he/she is required to contact On-Site Certification to notify of the cancellation.

#### **SAFETY POLICY**

In an effort to ensure our clients, visitors, customers, and staff members operate in a safe manner to both themselves and others, a safety policy is strictly enforced at all times. In addition to the following rules, a separate safety policy will be posted in the welding laboratory.

- Smoking or the use of electronic smoking devices in any form is strictly prohibited while on company property.
- Safety glasses are required at all times while in the welding laboratory or production areas.
- Safety glasses, earplugs, long sleeved 100% cotton work shirt, 100% cotton work pants, and leather work boots are required at all times while working in the laboratory.
- The following additional PPE will be required in the laboratory while welding, cutting, grinding, or sharpening tungsten:
  - Welding: ANSI approved welding hood with appropriate filter plate, welding cap (as needed) and welding gloves
  - Oxy-Fuel Cutting: ANSI approved No. 5 face shield and appropriate gloves
  - Hand Grinder: ANSI approved clear face shield or welding hood with flip lens and leather gloves
  - Sharpening Tungsten: ANSI approved clear face shield or flip lens style welding hood and NO gloves while using pedestal grinder
- Pant legs are to cover the upper portion of work boots at all times.
- Shirt tails shall be tucked in at all times while in the laboratory.
- Grinders shall have a proper guard installed at all times and be in good working order.
- At no time shall grinding sparks or torch spray be directed into the air, past a horizontal position or at another person.
- All gas cylinders are to be properly stored and secured while not in use, shall have a safety chain while in use, and chained and fitted with safety cap while being transported with a functional hand truck or dolly.
- Welding booths and cutting and grinding areas are to be cleaned and swept after each class or session, and trash, debris, floor sweep, and material shall be placed in proper locations, bins, or receptacles.
- Absolutely no headphones, earbuds or music is allowed in the classroom or laboratory.
- Mobile phones are to be kept on silent and used outside of the classroom or laboratory.
- All brooms, dust pans and equipment shall be returned to their proper place after each use.
- Proper instruction shall be given before operating any equipment.
- Housekeeping shall be treated as a top priority. Everyone is required to clean up at the end of each session, lesson, or class and as needed in order to insure a clean and safe work environment.



#### **DISCIPLINARY PROCESS**

On-Site Certification offers training that implements a particular philosophy centered on a spirit of excellence, and its leadership understands that learning is a process that involves the adoption and execution of different elements and methods used in learning. Some of these elements, fundamentals and practices allow for a period of time and acclamation, while others such as safety standards or inappropriate conduct do not.

- Any client behavior defined as inappropriate as outlined in any of the policies and procedures or deemed as such by an On-Site Certification staff member and that occurs on company property, may result in immediate dismissal by any staff member. In the event a staff member or any representative of On-Site Certification behaves inappropriately toward a client, a member of management should be informed immediately.



# CLIENT REFERENCE Textbooks



#### **GRADING POLICY**

On-Site Certification uses an "S" (Satisfactory) or a "U" (Unsatisfactory) as a means of establishing a pass/fail degree of success for completing a certificate course.

#### **INCOMPLETE OR WITHDRAW**

In the event a client is unable to complete the contact hours required for a Certificate of Completion, an "I" (Incomplete) or a "W" (Withdraw) may be awarded depending on the situation and intentions of the client. If a client is no longer able to attend, but has a desire to return at a later time and date, then an "I" may be awarded which will allow them the ability to return and continue where he or she left off, as long as it is within a specific amount of time as agreed upon by both parties. A "W" may be awarded in the event a client is no longer able to attend and either has no intentions of returning to the program at all or any time soon. At the discretion of On-Site Certification, a "W" may allow for some of the hours to be restored or applied in the event the client does decide to return and is also used to mark a healthy departing relationship between the client and On-Site Certification. Clients shall consult with an On-Site Certification staff member to proceed with the Incomplete or Withdraw process.

#### JOB PREPARATION ASSISTANCE

On-Site Certification is not required to provide our clients with job placement assistance. #### WELDER CERTIFICATIONS

The American Welding Society defines a welder certification as a written verification that a welder has produced welds meeting a prescribed standard of welder performance. This written form is also known as a Welder Qualification Test Record (WQTR) or Welder Performance Qualification Record (WPQR) and serves as a document of record and verification that a welder has passed a weld test in accordance to a particular welding code. On-Site Certification is equipped and able to provide welder certifications for prequalified Weld Procedure Specifications (WPS), qualified WPSs, as well as in some cases qualify certain WPSs to qualify or certify a welder.
